





• 6. Where do you typically access the trail?





I do this because I run long distance, between 6 to miles a night after work. If I st arted at the spot by sprinkles in one mile, going north I would need to run along the roads around the Glens falls CC. I refuse to run along roads where cars often travel over 40 or 50 miles an hour, don't s werve for pedestrians and come with in feet of pedestrians. Widen the shoulders to at least 10 feet fro m vechicals lower the speed limit, and or put up a guard rail to separate cars from bikes and pedestria ns. It's only a matter of time before someone is injured or killed in my opinion. The other option would be to find a way to connect the trail to northern part and by pass the roads. I'd really like to continue down the Feeder Canal trail past the falls, but going up Oakland Ave then on the road or sidewalk by Warren Street is downright dangerous. My daughter fell over on her bike there once; thankfully all the drivers stopped. Until an easement is figured out I look at them as two separat e trail systems - Feeder Dam to Glens Falls, and Shermantown / connection to LG Bikeway. I wish the re was a safer connection as riding for ice cream (Coopers Cave or Sprinkles) would be preferable to driving!

I walk here 5-10 miles daily. Unless traffic is very light, I avoid road crossings because they are unmar ked. Without markings, most local drivers act as if pedestrians need permission from drivers, usually d elivered through very special hand-signaling. The rest of the local drivers refuse to yield to pedestrian s entirely. A public education campaign is probably necessary since drivers education has clearly faile d. Earlier today I was forced to back out of a crosswalk where I had the signal and right-of-way but tur ning drivers refused to stop. This is extremely unsafe, especially for the young and old. I have lived in Portland, OR and Dallas, TX and Boulder, CO and Tulsa, OK and many more towns and cities across the US. This community is by far the most hostile to pedestrians.

I usually avoid the section from Iron Clad to Jack & Jill's ice cream when I ride alone. It often has hom eless, drunk/high people hanging out along the trail. I've also passed police talking to several people t hat have appeared under the influence mid morning and early afternoon along this section more than once. The gravel is also very tough to ride in.

I try to avoid the Country Club Road/Round Pond Road sections or go at 6 am to avoid the excessive speeds of vehicles. Even though there is a bike lane, those roads are very intimidating/unsafe becaus e of traffic volume and speeds.

I try to avoid sections with roads by doing an out and back, or my husband parks at one end and we d 1 rive point to point.

I really don't like the roadway near country club road.

I avoid the trail in downtown Glens Falls because of traffic. I would love to be able to have a safe plac e to ride all the way to Hudson Falls.

I avoid the streets in Glens Falls

I avoid the feeder canal for the last several years, mostly because it is unpaved. I have a hybrid bike a nd so I can ride it, but there can be unpleasant spots where rain gullies form or big bump onto or off of road crossings, etc.

I avoid most sections now as I have been stopped by people or seen people camping in the woods an d it feels unsafe. Specifically though I avoid going past the American Legion toward the Champlain trai I as I have been stopped by people back there and it feels isolated. Also avoid the strip that passes all the mills/plants as it feels very isolated back there as well.	1

• 10. Generally, when do you use the trail?






• 11. Which season(s) do you use the trail? Check all that apply.

Well behaved dogs should be allowed on the trails. I am currently opening a new business near the tr	
ail. I would sponsor a dog station	

We walk our leashed dogs almost everyday. Some bikers are very pleasant & slow down & announce they are behind us. Others some on electric bikes, don't slow down or let us know they are coming up behind us. Had a few times e-bike going about 30 miles an hour wiz by, no warning. Very dangerous.

We walk our dogs daily on the feeder canal trails. Bikers only warn us a small percentage of the time. Electric bikes should not be on this section of the trail, but they are and travel at high speeds. It is dan gerous walking dogs with high speed vehicles zooming past with little or no warning. Bikers should wa rn pedestrians on which side they are passing. They should give right of way to pedestrians. Electric motorized vehicles are not allowed on the trail (per signage) yet they act like they have right of way. El ectric bikes are supposed to ride on the roads which have speed limits of 30 mph or less. There could be a place for them on the canal trail if specific rules are made so pedestrians have rights of way. The feeder canal trails are highly used by people walking their dogs. Bikes and especially electric bikes m ake it dangerous for people and dogs when they do not yield and travel at high speed like everyone n eeds to get out of their way. Signage and enforcement needed.

We walk our dog on this trail (as do lots of other people we come across) and the dogs just seem to lo 1 ve it!

We walk on the bike trail daily. We have no problem sharing the space with bikers and walk single file when we see others passing. It is so helpful when a cyclist gives us a warning if they're approaching fr om behind with their bell or vocal heads up. It's so unsettling when they whizz by from behind (especi ally electric bikes and skateboards). I saw someone mention this in the chronicle and it truly helps us as pedestrians. Also when crossing bay road cars often don't know whether to stop or not. We actuall y would prefer that they don't. We've seen almost near pile up accidents from cars behind the stopped cars and then opposite side of the road cars don't always stop so it's very confusing. We appreciate th at the drivers mean well to stop but it really doesn't work and have almost caused drivers who aren't p aying attention to the stopped traffic in front of them.

We try to access the trail for running/cycling before 8:00 am in the summer. E-bikes users have added to the trail user load much more in the recent seasons but generally are more prevalent after 10:00 a m. The amount of dog walkers has increased significantly, especially from the Whipperwill RV park. It i s a wonderful asset for the county though I do not agree with allowing E-bikes on the trail. They go too fast, are usually less experienced and never wear helmets. I wish we could rename the trail to someth ing other than Bike path...maybe something like Rail to Trail.

We really need to deal with the issue of people walking dogs. There is no enforcement and it's danger ous.

We need better maps of the trails and how they interconnect. Some of the maps are more than 20 yea rs old. Keep the Jerry Lemo photos etc but update with clearer color maps	1

The trail is too narrow in areas populated by city residents. They walk 3 abreast. They don't pay attenti on to what is happening behind them. They have dogs on leashes that are a hazard. They seem to thi nk the trail was developed for walkers and not bicycles.

The trail is not usable during the winter as it doesn't get plowed and is often too icy to walk on or I wou 1 Id use it in Winter

The trail is mostly good the way it is. There are only two issues that I can see. One is e-bike riders wh o use the bike more like a motorcycle. They use the throttle only and don't pedal. They go at a high rat e of speed and this is dangerous for walkers. The other issue is dogs on the path in Glens Falls.

The trail is dated. Trails more recently built and less traveled roads in the areas we vacation in, take bi cycle tourism into consideration providing safer intersections and wider well marked shoulders. I think of our trails as an unrealized tourist attraction. When we travel, safe and interesting bike access in a c ommunity or attraction is a major factor in our decision to go. Properly managed and maintained, our t rails and less traveled roads, combined with existing access to our lakes, rivers and mountains, would be a national attraction.

The trail from glens falls to lake George is very well maintained and mowed. I have had few negative i nteractions with pedestrians and other bikers and have used the trail 2-3000 times. They should not al low any painting of mile markers on trail for Special events such as walks ,fun runs, etc.

The trail at the feeder dam end provides bags for dog cleanup (thank you !) But the closest garbage bi 1 n is up the hill by the picnic pavilion. Dog owners often use the bags, but then leave the full bags on th e ground right at the post where the bags are dispensed. I pick them up with my own and throw them away. A bin right at the bag dispenser is needed. Thanks.

The repaving from several years ago was wonderful, but the trail is now showing some areas of sinka ge (potholes) and some upheavals from roots. This needs to be a yearly maintenance project that is c ompleted during the week prior to Memorial Day weekend.

The rental eBike tourists can sometimes be problematic in terms of speeds exceed skill levels. Also d uring peak summer tourism season there are some sightseeing activities (strollers, earbuds, stops in middle of trail) that impede cycling pathway





There needs to be cameras

There is an interesting cast of characters on the stretch between Magic Forest and LG. Restroom acc ess is quite poor if you're unfamiliar with the area. On the LG end restrooms are plentiful if you know where you're going. On the GF end it's pretty terrible. The worst spot is on Gurney Ln/149 between G L MTB park and the municipal center. I know this is State owned road and DOT is probably completely disinterested, but this short corridor connects Gurney with the bikeway via Glen Lake Rd., provides ac cess to the outlets and Six Flags and is concurrently incredibly dangerous to navigate. There are no bi ke lanes, there is a lot of traffic, and I87 SB to Rt 9 is downright treacherous for motorists and cyclists alike. It is a matter of time before someone is killed. This whole area from 149 to the northway needs a hard reset, but DOT has made it clear that quality of life and pedestrian safety is none of their conce rn as long as the models indicate an adequate level or service.

There are way too many sketchy people on the trail. Several men have even commented about feelin g uneasy. There have been campsites along the trail as well, which should not be allowed. Also, E-bik es are an accident waiting to happen, especially the rented ones. There should be a governor on E-bi kes and scooters/skateboards on the trail, helmets should be required, and a quick lesson on staying t o the right should be mandatory.

There are some very dangerous crossings - Burgoyne/5 Combines and Warren Street (Connecting Ri 1 ver St & Boulevard) are probably the biggest concerns.

There are some road crossing signals near where the Bikeway meets the Feeder Canal Trail that do n 1 ot work. Can someone do an audit of all crossing signals within a mile radius of the trail?

There are some pavement sections that are in need of improvement, descending from bridge over 14 19.

There are several locations that facilities that encourage exercise would be easy to install and add ad ditional health benefits. Platforms and pull up bars like in Crandal Park spaced along the path would b e excellent.

There are LOTS of large dead trees hanging over the trail now that should be removed for safety reas 1 ons

The Zim Smith trail has officers on mtn bikes patrolling the trail, we need this for the Warren County tr 1 ail also, so women will not use the trail without security measures.

The wood posts restricting vehicles from entering the trails, should be removed as they create a hazar d to bikers. I have never seen a vehicle on the trail. Sanford street cross walk curbs do not meet ADA requirements. This street has been paved twice in the past 2-3 years and contractor failed to install sl oped asphalt to meet concrete curbs.

The trails were once ahead of their time. Feeder Canal needs improved connection to the City and the Glen/Shermantown connection.

The trail is such a wonderful addition to our region but there seems to be an increase in homeless peo ple spending time on the trail including an abandoned campsite that we found on the west side of the t rail between glen lake rd and 149. It would also be nice if people did not use the trail as dog walking tr ail.

The trail crossing on Bay St, just north of Garrison Rd would be greatly improved with the modern stre 1 et level pedestrian crossing flashing lights.

The stretch along Route 9 in front of Magic Forest needs guard rails that are highly resistant to vehicle s, much stronger than what is there now. Traffic moves very fast on the road, recent history has demo nstrated that real action to protect people on the path is needed. The curb cuts along that stretch shou Id be eliminated, Magic Forest can survive with access to their parking lot restricted to Bloody Pond R oad. Similar measures should be implemented on the next stretch south, from Bloody Pond Road to w here the path turns away from Route 9, as much as practical: vehicle-resistant guard rails and minimiz ed curb cuts. Additionally, the on-road sections along the golf course in Queensbury need much wider shoulders. Get rid of the utility pole in the middle of the path by Glen Lake! And please do frequent ma intenance on the trail pavement.

The simplicity of the trail is wonderful. Not too many signs which is good.

The section along Golf Course Road needs to be changed. I have too many cars coming too close wh 1 en I head north.

The safety out here is pretty good. Thanks for asking for our input.

The safety concern I have is for the part of the bike trail that starts when you get on Birdsall road. Som eone is going to get hit by a car either a walker or a biker. When driving up the hill (when your first turn on to birdsall) the bikes are all over the road. Not paying attention to cars. Then when they come dow n the hill they do not stop at the stop sign. Instead they cut in front of cars turning. The walker someti me do not want to get out of the middle of the road.

The road crossings are ok as long as vehicle traffic does not exist at the moment you are making an a 1 ttempt...not always but most of the time vehicles do not yield (nice when they do). Some of the crossi ng are also convoluted (i.e. Ridge St & Stanford St)

The road crossing safety is bad because of difficulty getting around the barriers.	1

My elderly parents visited and we cut our walk short because they needed bathrooms. In winter, we use daily for walks the snow melts and freezes repeatedly. It becomes quite dangerous. I think it w ould be better plowed for how the community uses it. Also there is a pedestrian crossing from Feeder Canal onto Haviland St. (And people do stop) but there is again no side walks connecting up to Knight St. Finally, I realize other recreation is not the topic right now but just want to put in place how many p eople would visit the area (and travel downtown to support businesses) if we invested in a whitewater feature at the Feeder canal dam. If you don't think it's popular check out the urban surf spots in Watert own NY, Franklin NH, London, Salida CO and Columbus GA.	1
