Mark the oval to the left of the name of your choice as such:

To vote for a candidate whose name is not printed on the ballot, mark the oval to the left of "write-in" and print the name clearly in the box labeled "write-in", staying within the box.

Any mark or writing outside the spaces provided for voting may void the entire ballot. You have a right to a replacement ballot.

Proposal Number One, An Amendment
Amendment to Protect Against Unequal Treatment

This proposal would protect against unequal treatment based on ethnicity, national origin, age, disability, and sex, including sexual orientation, gender identity and pregnancy. It also protects against unequal treatment based on reproductive healthcare and autonomy.

A "YES" vote puts these protections in the New York State Constitution.

A "NO" vote leaves these protections out of the State Constitution.
