Mark the oval to the left of the name of your choice as such:

To vote for a candidate whose name is not printed on the ballot, mark the oval to the left of "write-in" and print the name clearly in the box labeled "write-in", staying within the box.

The number of choices is listed for each contest. Do not mark the ballot for more candidates than allowed. If you do, your vote in that contest will not count.

Any mark or writing outside the spaces provided for voting may void the entire ballot. You have a right to a replacement ballot.

Proposal Number One, An Amendment
Amendment to Protect Against Unequal Treatment

This proposal would protect against unequal treatment based on ethnicity, national origin, age, disability, and sex, including sexual orientation, gender identity and pregnancy. It also protects against unequal treatment based on reproductive healthcare and autonomy.
