

WESTMOUNT STAFFING

THE HEALTH AND WELL-BEING OF 80 RESIDENTS IS OUR TOP PRIORITY TO THE MANAGEMENT AND STAFF OF WESTMOUNT

SKILLED NURSING FACILITY REQUIRES:

- 24 hour, 7day/week care for 80 residents who require skilled care.
- 2009 budgeted positions are in place to maintain adequate staffing throughout the facility required by law. (Fed/State guidelines)
- Our current nursing staffing pattern has not changed since the construction of this building in 1981.

CURRENT CNA, LPN, AND RN POSITIONS TO MAINTAIN ADEQUATE STAFFING FOR QUALITY OF CARE.

WESTMOUNT CONSISTS OF TWO NURSING UNITS. FORTY RESIDENTS PER EACH UNIT.

CURRENT VACANT POSITION: (1) FULL TIME 3-11 CNA.

- CNA PER DIEM USED AS MUCH AS POSSIBLE
- CNA OVERTIME USED WHEN PER DIEM NOT AVAILABLE

RISKS OF NOT FILLING VACANCIES IN NURSING STAFF:

- OVERTIME PAID TO FILL VACANT POSITIONS IS PAID TIME AND A HALF DEPENDING ON THE PERSON COVERING THE POSITION.

- IF WE ARE UNABLE TO FILL POSITIONS AS BUDGETED, WE WOULD NEED TO CONTRACT WITH A NURSE AGENCY.
- NO STAFF WILLING TO WORK OVERTIME TO FILL VACANT POSITIONS.
- MANDATORY OVERTIME POLICY PUT INTO PLACE DUE TO VACANT POSITIONS.

LIABILITY/UNION ISSUES:

- LACK OF QUALITY CARE FOR RESIDENTS DUE TO INSUFFICIENT STAFFING.
- INCREASE OF ACCIDENTS AND INCIDENTS AMONG THE RESIDENTS DUE TO INSUFFICIENT STAFFING.
- INCREASE OF ON THE JOB INJURY DUE TO CURRENT STAFF REQUIRED TO COVER VACANT POSITIONS. THIS RAISES COMPENSATIONS COSTS DUE TO BACK INJURIES, STAFF INCIDENTS, ETC.

BUDGETED POSITIONS WHICH HAVE BEEN VACATED DUE TO DEATH, RETIREMENT, RE-LOCATION, ETC.

- CNA'S HIRED AS OF 1/08 TO PRESENT: 10 TOTAL
- LPN'S HIRED AS OF 1/08 TO PRESENT: 4 TOTAL
- RN'S HIRED AS OF 1/08 TO PRESENT: 4 TOTAL

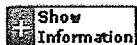
