Rationale: Warren County has an agreement through the New York State Office of Mental Health (Res. 101 of 2013) to administer the "Ticket to Work Program" which promotes employment to disabled persons. The county is eligible to receive payments when customers enter full-time employment based on certain thresholds. A payment was received on 7/28/14.
