

WHEREAS, certain New York State-owned lands which New York State has informed the Town are exempt were inadvertently charged for Water District charges, and

WHEREAS, Town and County records need to be corrected and Warren County will have to consider formally forgiving these water charges,

RESOLVED, that the Queensbury Town Board hereby requests that the unpaid Queensbury Consolidated Water District charges and all associated penalties and/or interest be forgiven for the following four (4) New York State owned properties:

3.0 CONCLUSIONS AND RECOMMENDATIONS

This office has completed the services summarized in Section 2.0 on specified portions of the property located at 4 Horicon Avenue, Town of Warrensburg, Warren County, New York. Services included the extension of eleven (11) soil borings, and the collection of six (6) soil and two (2) subsurface vapor samples to document the presence or absence of subsurface contamination potentially associated with historical discharges into five interior floor drains.

Based on the services provided and data generated, the following conclusions and recommendations (in **bold**) have been made.

No obvious contamination was observed in soils near the interior floor drains or at likely down gradient locations, and no significant contamination was identified in soil samples. Soil and sub-slab vapor samples document low levels of VOCs, which may be associated with fill materials or historical commercial uses of the subject property. A delineation of deep soils was not possible due to numerous refusals and no groundwater data has been collected; the absence of significant soil vapor contamination, however, suggests that these media are not substantially contaminated. These findings support the conclusion that historical releases at the floor drains (if any) have not resulted in significant impacts to the subsurface and have not impaired the utility of the property for commercial uses. Field observations suggest that some soils on the Site may require management as a regulated waste should excavation occur.

No further investigation is recommended at this time. All floor drains should be sealed to prevent future discharges to the subsurface.
