Mrs. Frasier called the meeting of the Health, Human & Social Services Committee to order at 11:34 a.m.

Mrs. Frasier indicated the purpose of the today's meeting was to discuss the Commissioner of Social Services position. She informed the Committee that Maureen Schmidt, the current Commissioner of Social Services, would be retiring in January of 2018. She opened the floor for discussion.

Ms. Braymer entered the meeting at 11:35 a.m.

Privilege of the floor was extended to Patricia Nenninger, Personnel Officer, who distributed copies of the New York Codes, Rules and Regulations CPR-NY 679.3 for the Department of Social Services to the Committee; *a copy of the handout is on file with the minutes.*

Ms. Nenninger reviewed the New York Codes, Rules and Regulations CPR-NY 679.3 and conversation ensued. The Committee decided to ask for five years experience for the position, to list the position Salary as being commensurate with experience; they also decided the position to be for one month and to include the vacancy in the Professional Journal.
