

Dear Gene:

In advance of our next meeting to give you time to consider.

We have had a large group of citizens that have been urging the Village/Town and State to create a Dog Park as an attraction for both residents and tourists. Several wishing to volunteer their time and efforts.

At a recent meeting we identified the Festival Commons as a potential site. It appears perfectly suited with a fence, grass, water, restrooms and parking. At little or no cost it could easily become a "Dog Park."

Obviously it would only be available during days not in use by others. An attendance is already on duty daily and the Village would supply dog stations.

The Village is willing to explore the use on a trial basis for the 2017 season. Dogs are presently permitted "on a leash" and that would require we change to "under control of a handler."
