RESOLUTION INTRODUCED BY SUPERVISORS GERACI, BRAYMER, SEEBER, DICKINSON, DRISCOLL, MCDEVITT AND DIAMOND

AWARDING BID AND AUTHORIZING AGREEMENT WITH NEMER FORD FOR PROPRIETARY DEALER ONLY REPAIRS FOR VARIOUS FORD MAKES AND MODELS (WC 39-22)

WHEREAS, the Purchasing Agent has advertised for sealed bids for Proprietary Dealer Only Repairs for Various Ford Makes and Models (WC 39-22), and

WHEREAS, the bids were opened on July 19, 2022 and the Sheriff has recommended that the bid be awarded to Nemer Ford, located at 323 Quaker Road, Queensbury, New York 12804, as the lowest responsible bidder, now, therefore, be it

RESOLVED, that the Warren County Purchasing Agent be, and hereby is, authorized and directed to notify Nemer Ford, located at 323 Quaker Road, Queensbury, New York 12804, of the acceptance of their bid, and be it further

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with Nemer Ford relative to Proprietary Dealer Only Repairs for Various Ford Makes and Models, in a form approved by the County Attorney, pursuant to the terms and provisions of the specifications (WC 39-22), for a term commencing October 1, 2022 and terminating on September 30, 2023, with the option for one (1) additional one (1) year term upon mutual agreement of the parties, and subject to the same prices defined in the attached Schedule "A," and be it further

RESOLVED, that the funds for this agreement shall be expended from Budget Code A.3110 441 Sheriff's Law Enforcement, Auto-Supplies & Repair.
