RESOLUTION INTRODUCED BY SUPERVISORS BRUNO, MAGOWAN, THOMAS, STROUGH, CONOVER, BEATY AND DIAMOND

AWARDING BID AND AUTHORIZING AGREEMENT WITH HI-LITE AIRFIELD SERVICES, LLC FOR FLOYD BENNETT MEMORIAL AIRPORT RUNWAY 1-19 REMARKING (WC 30-22)

WHEREAS, the Purchasing Agent has advertised for sealed bids for Floyd Bennett Memorial Airport Runway 1-19 Remarketing (WC 30-22), and

WHEREAS, the bids were opened on April 28, 2022 and the Superintendent of Public Works has recommended that the bid be awarded to Hi-Lite Airfield Services, LLC, located at 20128 NYS 12F, Watertown, New York 13601, as the lowest responsible bidder, now, therefore, be it

RESOLVED, that the Warren County Purchasing Agent be, and hereby is, authorized and directed to notify Hi-Lite Airfield Services, LLC, located at 21028 NYS 12F, Watertown, New York 13601 of the acceptance of their bid, and be it further

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with Hi-Lite Airfield Services, LLC for Floyd Bennett Memorial Airport Runway 1-19 Remarketing, in a form approved by the County Attorney, pursuant to the terms and provisions of the specifications (WC 30-22), for a term commencing upon execution by both parties and terminating upon completion of the project subject to the prices defined in the attached Schedule "A," and be it further

RESOLVED, that the funding shall be expended from Capital Project H414 Airport Runway 1-19 Remarketing Project.
