RESOLUTION INTRODUCED BY SUPERVISORS THOMAS, CONOVER, BEATY, FRASIER, WILD, BRAYMER AND RUNYON

AUTHORIZING AMENDMENT AGREEMENTS WITH THE POLICE SUPERVISORS BENEVOLENT ASSOCIATION, THE WARREN COUNTY CORRECTIONAL SUPERVISORS ASSOCIATION, THE WARREN COUNTY POLICE BENEVOLENT ASSOCIATION, THE WARREN COUNTY SHERIFF'S EMPLOYEES' ALLIANCE AND TEAMSTERS LOCAL 294, TO INCLUDE AN INTERIM WAGE INCREASE

WHEREAS, pursuant to Resolution No. 458 of 2019, the Chair of the Board of Supervisors was authorized to execute a Collective Bargaining Agreement on behalf of the County of Warren with the Police Supervisors Benevolent Association, for a term commencing retroactive to January 1, 2018 and terminating December 31, 2022, and

WHEREAS, pursuant to Resolution No. 629 of 2019, the Chair of the Board of Supervisors was authorized to execute a Collective Bargaining Agreement on behalf of the County of Warren with the Warren County Correctional Supervisors Association, for a term commencing January 1, 2020 and terminating December 31, 2022, and

WHEREAS, pursuant to Resolution No. 338 of 2021, the Chair of the Board of Supervisors was authorized to execute a Collective Bargaining Agreement on behalf of the County of Warren with the Warren County Police Benevolent Association, for a term commencing January 1, 2020 and terminating December 31, 2022, and

WHEREAS, pursuant to Resolution No. 339 of 2021, the Chair of the Board of Supervisors and the Warren County Sheriff were authorized to execute a Collective Bargaining Agreement on behalf of the County of Warren with the Warren County Sheriff's Employees' Alliance, for a term commencing January 1, 2021 and terminating December 31, 2024, and

WHEREAS, pursuant to Resolution No. 303 of 2022, the Chair of the Board of Supervisors and the Warren County Sheriff were authorized to executed a Collective Bargaining Agreement on behalf of the

County of Warren with the Teamsters Local 294, for a term commencing January 1, 2021 and terminating December 31, 2024, and

WHEREAS, the Personnel, Administration & Higher Education Committee has approved a request to execute amendment agreement with each of the five (5) bargaining units listed above to incorporate an interim wage increase of \$2.75 per hour effective retroactive to August 1, 2022 for all employees associated with any of the five (5) bargaining units, with the exception of part-time Patrol Officers working as School Resource Officers, now, therefore, be it

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an amendment agreement on behalf of the County of Warren with the Police Supervisors Benevolent Association, the Warren County Correctional Supervisors Association, the Warren County Police Benevolent Association, the Warren County Sheriff's Employees' Alliance, and the Teamsters Local 294 in accordance with the preambles of this resolution.
