**RESOLUTION INTRODUCED BY SUPERVISORS THOMAS, CONOVER, BEATY, FRASIER, WILD, BRAYMER AND RUNYON**

**AMENDING RESOLUTION NO. 547 OF 2022, AMENDING TABLES OF ORGANIZATION AND WARREN COUNTY SALARY AND COMPENSATION PLAN FOR 2022 TO PROVIDE INTERIM SALARY INCREASES FOR NON-BARGAINING UNIT EMPLOYEES FOR THE SHERIFF'S OFFICE, TO INCLUDE PART TIME POSITIONS WITH FULL-TIME BARGAINING UNIT COUNTERPARTS**

WHEREAS, by Resolution No. 547 of 2022 the Warren County Board of Supervisors amended the Tables of Organization and Warren County Salary and Compensation Plan for 2022 to provide interim salary increases for non-bargaining unit employees within the Sheriff's Office to match those previously authorized for CSEA employees and other non-bargaining unit employees, and

WHEREAS, the Personnel, Administration & Higher Education Committee has considered a request from the County Administrator's Office to amend Resolution No. 547 of 2022 to adjust the "Schedule A" attachment to include certain part-time positions within the Sheriff's Office which have full-time bargaining unit counterparts and does recommend same to the Board of Supervisors, now, therefore, be it

RESOLVED, that Resolution No. 547 of 2022 be, and hereby is, amended to reflect the attached revised "Schedule A" document and to indicate that all entries listed in said document be retroactive to August 1, 2022.
