AWARDING BID AND AUTHORIZING AGREEMENT WITH COUNTY WASTE & RECYCLING D/B/A ACE CARTING FOR SOLID WASTE, MEDICAL WASTE AND RECYCLING DISPOSAL SERVICES (WC 59-22)

WHEREAS, the Purchasing Agent has advertised for sealed bids for Solid Waste, Medical Waste and Recycling Disposal Services (WC 59-22), and

WHEREAS, the bids were opened on October 18, 2022 and the Superintendent of Public Works has recommended that the bid be awarded to County Waste & Recycling d/b/a Ace Carting, located at 1927 Route 9, Clifton Park, New York 12065, now, therefore, be it

RESOLVED, that the Warren County Purchasing Agent be, and hereby is, authorized and directed to notify County Waste & Recycling d/b/a Ace Carting, located at 1927 Route 9, Clifton Park, New York 12065 of the acceptance of their bid, and be it further

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with County Waste & Recycling d/b/a Ace Carting for Solid Waste, Medical Waste and Recycling Disposal Services, in a form approved by the County Attorney, pursuant to the terms and provisions of the specifications (WC 59-22), for a term commencing January 1, 2023 and terminating December 31, 2023, with the option for one (1) additional (1) year term upon mutual agreement of the parties, subject to the prices defined in the attached Schedule "A," and be it further

RESOLVED, that the funding shall be expended from various Departmental budget codes.
