Chairman Geraghty opened the meeting at 10:00 a.m.

Privilege of the Floor/Public Comment was called for, but there was no one wishing to speak.

Commencing the agenda review, Chairman Geraghty announced the purpose of the Workshop meeting was to discuss further the possibility of the County electing to become a member of the CDTA (*Capital District Transportation Authority*) and he turned the meeting over to Larry Elmen, *County Attorney*, who reviewed a Power Point presentation in detail regarding the legal aspects of Public Authority Law, Title 11-C and answered questions posed by the Board members; a copy of the presentation is on file with the meeting minutes.

Supervisor Braymer entered the meeting during the Power Point Presentation at 10:07 a.m.

A lengthy discussion ensued following which it was determined the County Attorney and County Administrator would work on compiling additional information to present at a future Committee meeting which included the possibility of providing assistance to GGFT (*Greater Glens Falls Transit*) to allow them to continue to operate rather than having the County become a member of the CDTA.

Privilege of the Floor/Public Comment was called for:

Gary Thornquist, *General Manager, Lake George RV Park*, implored with the Board members to seriously consider becoming a member of the CDTA, apprising if that was not the direction the County planned on taking then they needed to come up with a short-term plan that could be in place for the summer season to prevent any negative impacts on tourism which relied heavily on GGFT to provide transportation to employees and tourists throughout the County.

There being no further business to discuss, Chairman Geraghty closed the meeting at 11:19 a.m.
