RESOLUTION INTRODUCED BY SUPERVISORS RUNYON, GERACI, STRAINER, CROCITTO, TURNER, STROUGH AND MERLINO

AWARDING BID AND AUTHORIZING AGREEMENT WITH FREEPORT PRESS, INC. FOR 2026 WARREN COUNTY TRAVEL GUIDE PRINTING (WC 40-25)

WHEREAS, the Purchasing Agent has advertised for sealed bids for 2026 Warren County Travel Guide Printing (WC 40-25), and

WHEREAS, the bids were opened on September 11, 2025 and the Director of Tourism recommended, and the Tourism Committee agreed, to award the agreement to Freeport Press, Inc., 2127 Reiser Avenue SE, Philadelphia, Ohio 44663, now, therefore, be it

RESOLVED, that the Warren County Purchasing Agent be, and hereby is, authorized and directed to notify Freeport Press, Inc., 2127 Reiser Avenue SE, Philadelphia, Ohio 44663 of the acceptance of its bid after recommendations and approval have been received from the Director of Tourism, and be it further

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with Freeport Press, Inc. relative to 2026 Warren County Travel Guide Printing, pursuant to the terms and provisions of the bid documents and proposal (WC 40-25), for an amount not to exceed Ninety-Two Thousand Four Hundred Ninety Dollars (\$92,490) as defined in the attached Schedule "A," for a term commencing October 17, 2025 and terminating February 13, 2026, in a form approved by the County Attorney, and be it further

RESOLVED, that the funds for this agreement shall be expended from Budget Code A.6417.0001 470, Tourism/Occupancy, Tourism, Contract.
