RESOLUTION INTRODUCED BY SUPERVISORS THOMAS, GERACI, STROUGH, MADAY, DRISCOLL, CROCITTO AND MERLINO

AMENDING RESOLUTION NO. 139 OF 2024, AUTHORIZING THE CHAIR OF THE BOARD OF SUPERVISORS TO EXECUTE CONTRACTS WITH VENDORS OR CONTRACTORS UP TO \$10,000 UPON DEPARTMENT HEAD APPROVAL AND TO AMEND THE WARREN COUNTY PURCHASING POLICY ACCORDINGLY, TO DELETE BLANKET AUTHORITY PROVIDED TO THE COMMISSIONER OF SOCIAL SERVICES AND THE DIRECTOR OF PUBLIC HEALTH

WHEREAS, Resolution No. 139 of 2024, among other things, authorized the Chair of the Board of Supervisors to execute agreements with vendors or contractors regarding services required from time to time approved by Department Heads, for an amount not to exceed Ten Thousand Dollars (\$10,000) during a twelve-month period, except for blanket authorization provided to the Superintendent of Public Works, the Commissioner of Social Services and the Director of Public Health/Patient Services, and

WHEREAS, Resolution No. 410 of 2024, approved revisions to the Warren County Purchasing Policy, which incorporated blanket authorization to the Superintendent of Public Works, the Commissioner of Social Services and the Director of Public Health/Patient Services in Warren County Purchasing Policy Section III(A)(9), and

WHEREAS, the County Administrator requested, and the Finance & Budget Committee agreed, to remove the blanket authority provided to the Commissioner of Social Services and the Director of Public Health/Patient Services as provided for in Resolution No. 139 of 2024 and the Warren County Purchasing Policy Section III(A)(9), now, therefore, be it

RESOLVED, that Resolution No. 139 of 2024 be, and hereby is, amended to remove the blanket authority provided to the Commissioner of Social Services and the Director of Public Health/Patient Services, and be it further

RESOLVED, that the Warren County Purchasing Policy, as revised by Resolution No. 410 of 2024

be, and hereby is, amended to remove the blanket authority provided to the Commissioner of Social Services and the Director of Public Health/Patient Services as provided for in Warren County Purchasing Policy Section III(A)(9), by deleting, “the Commissioner of Social Services by Resolution No. 376 of 2017 and the Director of Public Health/Patient Services by Resolution No. 350 of 2023,” and be it further

RESOLVED, that other than the changes set forth herein, all other terms and conditions of Resolution Nos. 139 of 2024 and 410 of 2024 and the Warren County Purchasing Policy will remain the same.
