WHEREAS, the County Attorney requests that the Warren County Board of Supervisors authorize the Warren County Risk and Safety Committee to prepare and submit to the Finance Committee policies and procedures which reflect best practices in the State of New York for the transfer and disbursement of funds by electronic or wire transfer, to include but not be limited to ACH transactions, now, therefore, be it

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Warren County Risk and Safety Committee to prepare and submit to the Finance Committee policies and procedures which reflect best practices in the State of New York for the transfer and disbursement of funds by electronic or wire transfer, to include but not be limited to ACH transactions.
