ADOPTING AMENDED FEE SCHEDULE FOR THE WARREN COUNTY REAL PROPERTY TAX SERVICES DEPARTMENT

WHEREAS, the Warren County Real Property Tax Services Department prepares copies of tax maps, aerial maps, parcel maps, tax rolls and other real property documents for sale to the public, and

WHEREAS, the Warren County Board of Supervisors adopted an updated fee schedule for the Real Property Tax Services Department within Warren County by Resolution No. 381 of 2013 (previously authorized by Resolution No. 296 of 1987) and the fees have not been re-examined since that time, and

WHEREAS, the Environmental Concerns & Real Property Tax Services Committee reviewed the current fee schedule and made certain changes to the fees listed and recommends that the same be advanced to the full Board of Supervisors for consideration, now, therefore, be it

RESOLVED, that the attached fee schedule for the Real Property Tax Services Department within Warren County, be, and hereby is, adopted as the official fee schedule effective March 23, 2026, and be it further

RESOLVED, that any and all prior fee schedules, Resolutions or parts thereof inconsistent with the annexed are hereby repealed effective March 23, 2026.
