Copies of the meeting agenda were distributed; a copy of the agenda is on file with the meeting minutes.

Mr. Crocitto called the meeting of the Park Operations & Management (O&M) Committee to order at 10:45 a.m.

Mr. Patchett entered the meeting at 10:46 a.m.

Motion was made by Mr. Bruno, seconded by Mr. Patchett and carried unanimously to approve the minutes of the previous Committee meeting, subject to correction by the Clerk of the Board.

The Committee commenced with a review of the Action Agenda/New Business Items portion of the agenda, which consisted of a request to appropriate funds in the amount of \$6,353.30 from Budget Code A.691.07, *Deferred Revenue - Gaslight Village Parking Fees*, to Budget Code A.1625 413, *Charles R. Wood Park, Repair and Maint-Bldg/Property*, to authorize reimbursement to the Village of Lake George for the Charles R. Wood Park Playground Slide Purchase.

Motion was made by Mr. Bruno and seconded by Mr. Niles to approve the request as presented; following discussion, Mr. Crocitto called the question and the motion was carried unanimously to approve the request as outlined above and refer same to the Finance & Budget Committee. *A copy of the resolution request form is on file with the minutes.*

The Discussion Items portion of the agenda, which included the following item, was reviewed:

1. Festival Space update.

Privilege of the floor and public comments were called for, but there was no one wishing to speak.

There being no further business to come before the Park Operations & Management Committee, on motion made by Mr. Patchett, seconded by Mr. Niles and carried unanimously, Mr. Crocitto adjourned the meeting at 10:51 a.m.
