RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with R.M. Dalrymple Co., Inc. relative to Fuel Maintenance Services, pursuant to the terms and provisions of the bid documents and proposal (WC 20-26), as defined in the attached Schedule "A," for a term commencing June 1, 2026 and terminating May 31, 2027, with the option for two (2) additional one (1) year terms, upon the same terms and conditions and upon mutual agreement of the parties, in a form approved by the County Attorney, and be it further

RESOLVED, that the funds for this agreement shall be expended from Budget Code DM.5140 422 Road Machinery, Motor Fuel Farms, Repair/Maint-Equipment.
