AWARDING BID AND AUTHORIZING AGREEMENT WITH RICHARD SEARS TREE EXPERTS FOR TREE REMOVAL SERVICE IN CHESTER, NY (WC 22-26)

WHEREAS, the bids were opened on April 16, 2026 and the Superintendent of Public Works recommended, and the Public Works Committee, agreed to award the bid to Richard Sears Tree Experts, 16 Harold Harris Road, Queensbury, New York 12804, now, therefore, be it

RESOLVED, that the Warren County Purchasing Agent be, and hereby is, authorized and directed to notify Richard Sears Tree Experts, Harold Harris Road, Queensbury, New York 12804 of the acceptance of its bid, and be it further

RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with Richard Sears Tree Experts relative to Tree Removal Service in Chester, NY, pursuant to the terms and provisions of the bid documents and proposal (WC 22-26), as defined in the attached Schedule "A," for a term commencing upon execution by both parties and terminating upon completion of the project, in a form approved by the County Attorney, and be it further

RESOLVED, that the funds for this agreement shall be expended from Budget Code D.5110 470, County Road, Maintenance of Roads, Contract.
