RESOLVED, that the Warren County Board of Supervisors hereby authorizes the Chair of the Board of Supervisors to execute an agreement with Krystal Automotive, Inc. d/b/a Krystal Chrysler Dodge Jeep Ram Fiat relative to Proprietary Dealer Only Repairs for Various Dodge, Chrysler and Jeep Makes and Models, pursuant to the terms and provisions of the bid documents and proposal (WC 32-26), as defined in the attached Schedule "A," over a term commencing October 1, 2026 and terminating September 30, 2027, with the option for two (2) additional one (1) year terms, upon the same terms and conditions and upon mutual agreement of the parties, in a form approved by the County Attorney, and be it further
