RESOLUTION INTRODUCED BY SUPERVISORS ETU, CROCITTO, CONOVER, MADAY, BRUNO, STROUGH AND RUNYON

AMENDING RESOLUTION NO. 203 OF 2026, WHICH AUTHORIZED APPROPRIATIONS FROM BUDGET CODE A.863.00, RESERVE, INSURANCE, TO FUND PROPERTY AND CASUALTY SELF-INSURED DEDUCTIBLE LINES FOR THE DEPARTMENT OF PUBLIC WORKS; WARREN COUNTY SHERIFF'S OFFICE; DEPARTMENT OF SOCIAL SERVICES; WARREN COUNTY HEALTH SERVICES; PROBATION DEPARTMENT AND DISTRICT ATTORNEY, TO ADD ADDITIONAL APPROPRIATIONS TO THE WARREN COUNTY SHERIFF'S OFFICE

WHEREAS, pursuant to Resolution No. 40 of 2026, the Warren County Board of Supervisors authorized the appropriation of One Hundred Thousand Dollars (\$100,000) from Budget Code A.863.00, Reserve, Insurance, to Insurance Reserve-Deductible (A.1610 418.1) under the Department of Public Works (\$25,000); Insurance Reserve-Deductible (A.3110 418.1) under the Warren County Sheriff's Law Enforcement (\$25,000); Insurance Reserve-Deductible (A.6010 418.1) under the Department of Social Services (\$25,000); Insurance Reserve-Deductible (A.4010 418.1) under the Warren County Health Services (\$25,000); Insurance Reserve-Deductible (A.3140 418.1) under the Probation Department (\$10,000); and Insurance Reserve-Deductible (A.3140 418.1) under the District Attorney (\$10,000), and

WHEREAS, the County Attorney requested, and the Finance & Budget Committee agreed, to appropriate an additional Forty Thousand Dollars (\$40,000) from Budget Code A.863.00, Reserve Insurance, to Insurance Reserve-Deductible (A.3110 418.1) under the Warren County Sheriff's Law Enforcement, now, therefore, be it

RESOLVED, that the Warren County Board of Supervisors hereby appropriates the sum of Forty Thousand Dollars (\$40,000) from Budget Code A.863.00 Reserve, Insurance, to Insurance Reserve-Deductible (A.3110 418.1) under the Warren County Sheriff's Law Enforcement for payment of out-of-pocket commercial deductible property and casualty claims and actions incurred during 2026 that do not exceed the sum of Twenty-Five Thousand Dollars (\$25,000), upon the approval of the County Attorney, which the County Treasurer is hereby authorized and directed to make, and be it further

RESOLVED, that the Warren County budget for 2026 be, and hereby is, amended accordingly.
